**Policies:**

- The Washington State Convention & Trade Center prohibits all food and beverage not approved of, or supplied by ARAMARK, the exclusive caterer of the Convention Center. **Booth deliveries are not billed on consumption.**
- We strongly recommend that all orders are placed in advance. **On-site orders and re-orders require advance notice and are subject to product and staff availability.**
- Payment is due prior to delivery by credit card or check.
- All prices are subject to an 18% service charge and a state sales tax, currently at 9.3% and are subject to change.
- The Customer is required to arrange for any electrical outlets that may be needed to support their food & beverage service. All orders must fit entirely within the exhibitor's booth.
- Service staff is available for your booth for an additional charge. Service staff is **required** when your service includes equipment, alcoholic beverages.
- There will be a **\$25.00 service charge** for all orders of **\$100 or less.**

Orders must be received no later than ONE WEEK prior to service date. All orders received less than one week in advance will be subject to product and staffing availability. A late fee of 10% will be added to all orders placed within one week of the service date.
