Faculty are required to provide outstanding teaching to residents, fellows, medical students, and master's students. The selected candidate will be appointed at the level of Associate or Full Professor in the In Residence, Clinical X, HS Clinical, or Adjunct series.

- MD PhD degree (or equivalent), or MD (or equivalent) with ability to practice clinical Radiology in California.
- Associate Professor rank or above in any academic series.
- Must be a recognized leader in radiology research with expertise in breast imaging.
